

Kalamazoo Valley Community College:

CARES Act - Higher Education Emergency Relief Fund Reporting

Kalamazoo Valley Community College (OPEID 006949) signed and returned to the Department of Education the Certification and Agreement for CRRSAA and ARP. KVCC's allocation of funding received through CRRSAA that must be used for the student emergency grants is \$2,124,650. As of September 30, 2021, all CRRSAA student portion funds have been paid to students. KVCC's allocation of funding received through ARP that must be used for student emergency grants is \$8,338,989. As of September 30, 2021, \$4,155,150 of ARP student portion has been paid to students as emergency grants.

Kalamazoo Valley Community College (OPEID 006949) signed and returned to the Department of Education the Certification and Agreement for Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economics Security (CARES) Act on April 22, 2020. KVCC's allocation of funding received through the CARES Act is \$4,249,299. KVCC used no less than 50% of the funds (\$2,124,650) received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants directly to students. As of September 30, 2021, all CARES Student Share funding has been paid directly to students.

As of September 30, 2021, all CARES funding, \$2,124,650, has been paid directly to 1617 students.

As of September 30, 2021, all CRRSAA student portion funds, \$2,124,650, have been paid to 1851 students.

As of September 30, 2021, \$4,155,150 of ARP has been paid to 3243 students.

In the 2021-2022 school year, as of September 1, 2021, 2542 students were identified as having exception need (EFC 7400 and below). 9196 unduplicated FAFSA's were submitted to KVCC. As of October 7, 2021, Kalamazoo Valley had 6878 students enrolled in the Fall 2021 semester.

In the 2020-2021 Award Year, 5694 students were identified as having exceptional need (EFC 7000 or Below). 9196 unduplicated FAFSA's were submitted and Kalamazoo Valley had an unduplicated headcount of 10,095 students. 7921 unduplicated FAFSA's were uploaded to Kalamazoo Valley's system. Kalamazoo Valley had an unduplicated headcount of 10,095 students during the 2020-2021 school year.

Fall 2021 ARP Funding:

KVCC students must complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as "Valley CARES" under the "My Links" section in the MyValley. For Fall 2021, the application became available the first day of the semester, September 8, 2021. KVCC began awarding, disbursing and processing refunds for Fall 2021 enrolled students who applied on this date.

Through the Valley CARES application, students identify that they have personal expenses caused by the disruption of campus services due to COVID-19. Students who identified having a personal expense were

awarded \$1200 or, to prioritize needy student as required by ARP, students with an EFC below 7400 received an additional \$100 in emergency grant awards if they submitted the Valley Cares Application.

Summer 2021 CRRSSA and ARP Funding:

KVCC students must complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as “Valley CARES” under the “My Links” section in the MyValley. For Summer 2021, the application became available the first day of the semester, May 10, 2021. KVCC began awarding, disbursing and processing refunds for Summer 2021 enrolled students who applied on this date.

After receiving CRRSSA & ARP funds, KVCC Valley CARES Task Force decided to continue with the process for application established November 15th. Through the Valley CARES application, students identify that they have personal expenses caused by the disruption of campus services due to COVID-19. Students who identified having a personal expense were awarded \$500 or, to prioritize needy student as required by CRRSSA and ARP, students with an EFC below 7000 received an additional \$200 in emergency grant awards.

Winter 2021 Semester/CRRSAA Funding

Winter 2021 CRRSAA Funding

KVCC students must complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as “Valley CARES” under the “My Links” section in the MyValley.

After receiving CRRSSA funds, KVCC Valley CARES Task Force decided to continue with the process for application established November 15th. Through the Valley CARES application, students identify that they have personal expenses caused by the disruption of campus services due to COVID-19. Students who identified having a personal expense were awarded \$1000 or, to prioritize needy student as required by CRRSSA, students with an EFC below 7000, were awarded \$1200. FAFSA is also required in all cases except high school students in most cases during the Winter 2021 due to prior guidance from the Department of Education. Through the CARES application, high school students are asked if they meet the citizenship/eligible non-citizen eligibility criteria. If yes, they are awarded \$1000.

Fall 2020 Semester/CARES Funding – Final Report for CARES funding

The estimated total number of KVCC students eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 is approximately 3,384 students. As of September 30th, KVCC has issued \$1,265,208 Emergency Financial Aid Grants from CARES directly to 1230 KVCC students for the 20-21 school year, based on the applications students have submitted to request these funds for the Fall 2020 semester. KVCC students must complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as “Valley CARES” under the “My Links” section in the MyValley.

The application provides instructions to students that they must have a current FAFSA on file with KVCC

and meet Title IV eligibility requirements. Through November 15th, the application required students to confirm they have technology related the expense(s) incurred related to a disruption of campus services due to COVID-19. Students who identified having a technology related expense were awarded \$700 in CARES. On November 15th, the application was updated to allow students to identify that they had person expenses caused by the disruption of campus services due to COVID-19. Students who identified having a personal expense were awarded \$1000.

2019-2020 Award Year/CARES Funding - Final

The estimated total number of KVCC students for Winter 2020 eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 is approximately 3,711 students. As of September 30, 2020, KVCC has issued \$375,673 in Emergency Financial Aid Grants directly to 362 KVCC students, based on the applications students have submitted to request these funds for the Winter 2020 semester and two students in our Winter Academy term received \$3150 in funds. KVCC students had to complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as “Valley CARES” under the “My Links” section in the MyValley.

The estimated total number of KVCC students for Summer 2020 eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 is approximately 1,395 students. As September 30, 2020, KVCC has issued \$473,319 in Emergency Financial Aid Grants directly to 379 KVCC students, based on the applications students have submitted to request these funds for the Summer 2020 semester. KVCC students had to complete an application for Emergency Financial Aid Grants through their MyValley Account. The application is listed as “Valley CARES” under the “My Links” section in the MyValley.

The application provided instructions to students that they must have a current FAFSA on file with KVCC and meet Title IV eligibility requirements. The application requires students to identify the expense(s) they incurred related to the campus closing, and all operations and services being moved to an online format. Eligibility for Emergency Financial Aid Grants for KVCC students is based on financial issues they have had or will face related to moving to campus disruption, such as internet service issues, the need for a new computer or special software or hardware, or increased utility costs. The KVCC CARES Act Task Force developed the following guidelines for determining the Emergency.

Financial Aid Grant amounts:

- \$500 – Computer Purchase
- \$500 – Course Materials (Books, Supplies, Paper, Printer Cartridges, etc)
- \$200 – Other Technology Related to Online Courses (e.g. webcam, microphone, printer)
- \$200-400 (per month) – Increased household costs
- \$50 (per month) – Healthcare costs
- \$100-200 (per month) – Food Costs
- \$100-200 (per month) – Internet Service Contract

Extenuating Circumstance Costs – evaluated individually

Each student’s situation is evaluated individually based on the information provided in the student’s application, and KVCC maintains the flexibility to increase the amount awarded per eligible expense to

each student on a case-by-case basis.

KVCC students were notified about the availability of these Emergency Financial Aid Grants, the requirement to meet Title IV eligibility criteria, and the application to apply for the funds via a press release, email notifications, text messages, the KVCC website and social media postings.
