

Bank transfer

Bank transfer is the most commonly used payment method. We offer local currency bank transfers in 52 currencies and 69 countries. Exchange rates on bank transfer payments are held for 72 hours, giving students visibility on the amount they need to pay and protecting them from any exchange rate movements. In recent months we have added new local bank account for a number of currencies including Indian Rupee, Vietnamese Dong, Brazilian Real, Colombian Peso, Philippine Peso, Thai Bhat and Indonesian Rupiah.

For some countries, students will be required to upload documentation to comply with local regulations.

To do this, the student must first initiate the transaction and receive a quote on the platform. They will then be provided with instructions on how to complete the transaction with their chosen agent.
